2. It is informed that the matter to extend the delegation of powers to the Administrative Departments in respect of 'Bank of Sanctions' has been reconsidered and it has been decided that henceforth the Administrative Departments have been allowed to issue administrative approvals of Rough Cost Estimates for construction/maintenance of Government buildings from 2 to 2.25 times of the current budgetary provisions. Further, in most exceptional circumstances where the said exercise fails in the opinion of the Administrative Department to accommodate the urgently needed activity, a reference may be made to the Finance Department to extend the limit of 'bank of sanctions' upto 2.5 times of the current budgetary provision.

3. All the other conditions as laid down in the instructions dated 18.12.2008 will remain operative.

4. These instructions may kindly be brought to notice of all concerned for strict compliance.
