

One Family One Job

One family one job scheme came into existence w.e.f. 1-12-1992 in Haryana. Eligible applicants can register their names under this scheme. The terms and conditions for registration under OFOJ scheme are as follow:-

Terms and Conditions:-

1. He/ she should be between the age-limit of 18 to 35 years. (Relaxable for SC or BC applicants upto 5 years)
2. He/ she should be a resident of Haryana State.
3. No member of his/her family should be in any kind of employment in Public or Private Sector.
4. No member of the family should be an income tax or sales tax payee.
5. No member of such family should be an Ex. or Current MP/MLA or a Chairman of any Board/Corporation/Undertaking etc.

The applicant has to produce three documents under this scheme

- A self-declaration form as per the prescribed format.
- An attested copy of his/her Haryana domicile certificate.
- A self-declaration form containing the details of his/her adult family members.
